Denison Middle School Principal Patti Ryan received a surprise message last week Wednesday.

Since the school's landlines were not working, she received a text from Toby Young, middle school principal with MMCRU (Marcus-Meriden-Cleghorn/Remsen Union) that she had been named the 2024 Iowa Middle Level Principal of the Year by the School Administrators of Iowa (SAI).

"It is truly an honor to be selected," Ryan said. "It is exciting to represent Denison Community Schools and the State of Iowa. The first thing I did was tell my kids!"

Ryan, a 1985 Denison High School graduate, has been the Denison Middle School principal since 2017, and a secondary curriculum director.

Before becoming the middle school principal, she served in school

From 1997 to 2005, Ryan taught seventh grade math at Denison M i d d l e

School, and before that taught fourth- through sixth-grade math for four years at Ar-We-Va. She served as a substitute teacher for two years when her children were young before entering the education field full time in 1993 at Ar-We-Va.

Denison agrees to mutual benefit arrangement with prison industries

The Denison City Council last week voted in favor of an agreement that would help to jump start projects in the city while also benefitting individuals who are incarcerated at a minimum-security facility with the Iowa Department of Corrections.

The city council voted to allow City Manager Jessica Garcia to sign an incarcerated individual work agreement with Iowa Prison Industries (IPI)

The agreement is for one year.

The city envisions using incarcerated individuals from the Department of Corrections North Central Correctional Facility in Rockwell City

to help the public works department with tree removal and the parks department with park maintenance.

Rod Olson, director of public works, has had training in the program at Rockwell City. Garcia said she would also like to have Sam Ellis, parks and rec director, and Manny Barroso with the parks department receive the same training.

Under the return-to-work program certain individuals who are incarcerated are certified for work. The program assists with lower recidivism rates, helps individuals obtain workforce skills and helps them earn money to pay fines and restitutions, Garcia explained.

Biomass plant opening in Odebolt; will have Crawford County reach

Corn stover remaining after harvest in fields around Odebolt soon can be used for producing a corn board, which can be used in products like skis and delivery pallets, at a facility being developed in Odebolt, the company's founder and CEO Lane Segerstrom told The Denison Free Press.

The for-profit company is early in the stages of breaking ground and building a complex that will produce 10 million square-feet of corn board for flat-board pallets for distribution and manufacturing centers.

The facility will be a mile and a half west of Odebolt on Highway 175. It rests on 40 acres and will be 50,000 square feet under roof in

multiple buildings.

"We are hoping this spring or summer to break ground," Segerstrom said.

He expects the project to be completed within 18 months.

The radius for farmer contracts will stretch about 20 miles. Corn Board expects to need 50 tons of stover and could have contracts with up to 80 farmers.

"There was a group of farmers that really wanted us to come there and it seemed like it was fitting as I am from that area," said Segerstrom, an Ida Grove native. "It seemed like all the things were aligning."

Corn Board expects to have 35 employees, full-time.

Just about two years ago, she was able to cut back on her hours as a project analyst so she could dedicate even more of her time to taking pictures of events. This allowed her to attend anywhere from eight to 16 hours of school activities per week - even some out of town activities.

People will also find Rhonda attending any state event that involves a Denison athlete. From the state wrestling meet to playoff football games, she makes sure that these athletes are recognized for their hard work and dedication to their activity with lots of photos available to their

The impact she has on the Denison Community School District and its students does not go unnoticed. 

Garcia said many other cities that directly to the individuals but pays IPI. are within Region XII use the program as an opportunity to get some extra assistance and work done within their

Garcia explained that there are two programs. One is a supervised group in which from three to up to 20 individuals come to the community to work and have a supervisor along with them. The city pays a flat rate per hour based on the number of individuals that come to the community to work.

Garcia said she discussed with Olson that one of those projects would be to take down dying and deteriorating trees in the city right of way at a quicker rate, using a larger number of workers.

"Please understand this is not to replace the work of any other full-time employees," Garcia told the council members. "It says that right in the agreement that we're not using this to replace hiring any other full-time

Garcia said that in conversation with Martin Chase, off-grounds supervisor with IPI, the end of May or early June is as soon as the City of Denison could get on the calendar for workers.

Garcia explained the second option or program is an off-site incarcerated individual work agreement. In this option, the workers have to be supervised by someone who has gone through the training with the IPI, like Olson.

"We've been in conversation with Martin (Chase) about Sam (Ellis) and Manny (Barroso) going to the next training so that they can get some help with painting shelters, renovating shelters and doing some of those pieces of work," said Garcia.

She added, "The individuals that get approved to do off-site work, whether it is supervised or unsupervised, have to go through a specific set of certifications. They do not certify anybody who has had any violent crime offense or anybody who has an offense that would land them on the registry. Those individuals are prohibited from being certified to do work."

"What we were told is most of the individuals will be low level offenders, people that have to do a few months for maybe drug or alcohol violations and usually are individuals that are within a very close timeline of being released," Garcia continued.

She added that the agreement with IPI has gone through the city's insurance agent and city attorney. The state insures the incarcerated individuals so they are not considered employees of the city.

The city also does not pay the money

IPI keeps track of the work hours of the individuals and disperses the pay according to their rules and regulations.

Olson said the incarcerated individuals who are certified to work, work hard for that opportunity.

He said it is a great opportunity for the individuals.

"These are good people. They just made the wrong choice at one time," he added."Most are trying to make money to pay the fines, but then again they're trying to make money to get started

when they get out."

Asked if the work program was a seasonal option only, Garcia said she had not gotten into that detail with Martin Chase, if there is work that the individuals can do or would be interested in doing in the winter. Right now, it is seasonal work.

She added that she is in an email chain with five other communities that are in the geographical line from Rockwell City, to work on a way to lower transportation costs.

"We have to pay per loaded mile, so we're trying to find a way where, if it is approved by all of our respective councils, that we can find similar days so that we can get one group of individuals, so maybe it's a Thursday and Friday, but then Region XII only does one day of transportation, drops them off and picks them up, and they do all the transportation."

Meals are sent with the individuals. Garcia said the incarcerated individuals do not show up in orange jumpsuits. Olson added they wear orange jackets or pullovers.

The rules for the incarcerated individuals are strict, and city employees must also observe the rules of the IPI and the Department of Corrections. The incarcerated individuals can't have access to tobacco, alcohol, cell phones or anything like that. If city workers would give items like that, the city would be in violation.

Garcia said as soon as the incarcerated individuals get back to Rockwell City, they are tested for nicotine, alcohol or any other substances, and if any substances are found, they would lose the privilege of going out to work.

Garcia said if the council is fine with the program, the city would like to start with the large, supervised group option to get the individuals to town to help with trees or street patching, fixing pieces of recreation trails and other types of work.

The individuals will be trained according to the type of work they will

"Teachers I had in the Denison district were some of the best role models," she said in an email interview with The Denison Free Press.

"Mrs. Collette Huntley was certainly a standout for me as a new middle schooler struggling to fit in and to be myself at the same time. As a new teacher, Mr. Bob Gress, former Ar-We-Va elementary principal, was so encouraging and supportive and I still think often of his advice to always keep learning," Ryan said.

She said she loves what she gets to do every day at Denison Middle School.

"The things that are most fulfilling are watching students and teachers grow and learn," Ryan explained. "Middle school students mature so fast, and when we send them off to high school, they are young adults where they came to us as 11-12 year olds. That is second on my list, and on the top is seeing them graduate just four short years later, ready to take on what is next in their adult lives.

'We are all working to have a thriving culture in our school, and the people I get to work with - from the transportation department that get the kids to us safely to the maintenance staff that keep everything up and running to the kitchen staff who joyfully feed our kids to the leaders, teachers, and support staff who guide our kids - all simply amaze me."

March 8, 2:10 a.m.: The Crawford County Sheriff's Office investigated a single-vehicle accident that happened on 130th Street. Ana Yicel Ramirez Flores, 55, of Charter Oak, was driving a blue 1998 Ford Econoline and was traveling in a northwest direction north of Meeves Ridge Road, entering a right curve to travel north. The roadway was snow covered and slick. The driver lost control of her vehicle. It entered the west ditch and rolled, coming to a rest on its right side. Historic Preservation Commission seeks grant submissions

The Crawford County Historic Preservation Commission is now offering grants to be distributed this summer. Eligible recipients are groups that are improving historic sites that are open to the public.

The commission is able to send applications to all who qualify. Applications can also be picked up at the auditor's office on the second floor of the Crawford County Courthouse.

Details and qualifications are as follows.

- The site must be located in Crawford County, can be publicly or privately owned, and must be accessible to the public. Properties used for personal residence and/or private use do not qualify.
- Improvement projects have been started and completed between May 31, 2023, and June 1, 2024. Projects completed before May 31, 2023, do not qualify.
- Improvements include things like landscaping, painting, wallpapering, refinishing wood, minor repairs, etc. Projects must enhance or improve the historic value of the property.
- + Receipts for completed projects must be submitted. Estimates in the form of vendor statements or written estimate quotes must be submitted for all projects started or contemplated. All

evidence statements must be submitted with the grant application form.

- No applications will be considered that are postmarked or hand delivered to the county auditor's office after May 15.
- All projects must be completed on or before June 1, 2024.
- Grant funds will be paid after the completion of the project.

commission encourages improvement projects, regardless of whether they involve sites listed on the National Register of Historic Places. Crawford County is full of historical sites, several of which are on the National Register of Historic Places. Local sites on the registry include the John Carey House, Clarence Chamberlin House, W.A. McHenry House, the Park Motel, Denison Opera House, Crawford County Courthouse, all in Denison; the Klondike Hotel in Manilla, the Dow House in Dow City, and the Z.T. Dunham Stock Farm near Dunlap.

The commission is dedicated to assisting all persons interested in maintaining and/or creating places of historical significance for public use and enjoyment. Proxy consent forms, used for picking up another person's food, will not need to be renewed unless there are changes. People are asked to abide by the policy of one allotment of food per household.



Larry Joseph Halbur January 6, 1942 - February 29, 2024


