## Movies in the Park is Saturday

## "The Super Mario Bros. Movie" to be screened

Movies in the Park returns to Denison on Saturday with a showing of "The Super Mario Bros. Movie" at Washington Park.

"I usually stay away from the more recent movies because people have seen them recently, but 'The Super Mario Bros. Movie' is so good," said Jennifer Smith, who is the lead organizer of the event.

"It really speaks to anybody who is three years old to about 70 who grew up around Nintendo. It really reaches across generations, so everybody can be a part of it."

The animated movie was released on April 5 of this year, and went on to earn \$1.36 billion dollars on a \$100 million budget.

"The Super Mario Bros. Movie" stars Chris Pratt, Anya Taylor-Joy, Jack Black and many others in voice roles.

As sponsor of the September Movies in the Park event, Broadway Dental will cover the licensing fee for the film, which was \$480.

"They are third-year sponsors for our movie night and we love having them be part of the festivities," Smith said.

She noted that the licensing fees started at \$435 two years ago and have steadily increased.

After three full weeks of rehearsals, the cast of "Mary Poppins" ran through the entire production for the first time.

Every four years, the Denison Community School District puts on a community musical with a cast of students and adult members from the community; "Mary Poppins" is the

2023 production. "We have lots of talented adults and students," said DHS vocal teacher Kandice Thompson, who is codirecting the musical with Denison High School (DHS) language arts teacher Laurel Ölsen.

"I feel like we're ahead of schedule, so that's exciting."

Thompson handles the singing parts of the rehearsals and Olsen directs the acting performances.

Rehearsals to this point have involved scene blocking and choreography for each of the scenes, as well as work with Thompson to learn the musical's many songs.

Ölsen said the run-through this week would help her determine what

A new building under construction in Denison will house a business Cody Mohr started in Schleswig about five years ago.

"I needed a shade for our cattle and a couple of the brands I was going to buy took you three hours or so to put it together," Mohr said.

He instead decided to create a shade of his own.

"I invented a shade that cranks up and collapses just like an umbrella," he said. "It comes all preassembled with the canvas and ready to go."

He made two for himself, and two more for someone who liked the design.

As more people heard about his shade, a few more orders came in.

Production of Mohr Shades will soon be underway in this building in south Denison. The company sold about 300 of the collapsible shades last year and aims to sell more than that in the coming year.

"Our first year, we sold 13," he said. "The second year, it was 50."

Last year, he sold 300.

"I didn't really plan on it being much, but it turned into quite something," Mohr said.

For the last five years, he and a few others have been making Mohr Shades at Bedrock Concrete Products in Schleswig.

Mohr Shades have been put to use by the Denison Community School District for softball, baseball, and track and field events.

A few have been placed in city parks, and the shades have proven to be popular with livestock producers.

She expects to be done with most of the scenery in the next two weeks.



Growing up on a farm just north of Halbur, her experience and expertise in agriculture started at a young age.


"My summers were filled with 4-H, county and state fairs, walking beans, and helping out on the family farm,"

"A really good thing about this community is when there are things to do, things born out of an intent to do good, people recognize that and they step up to lend a hand," she said.

## Ballot names set for November 7 city/ school elections

## Kris Rowedder retiring from Denison School Board

The names for the November 7 city and school elections are set. Last Thursday was the last day to file nomination papers.

One school election change will be the retirement of Kris Rowedder from the Denison School Board. She is in her 21st year on the board and had served as president of the board for a number of years. When she knew she was not going to run again, she stepped down as president two yeas ago to give other board members the experience of serving in that capacity. Louis Scheuring is the current board president.

Filing for the two seats up for election on the Denison School Board are Derek Lambert, an incumbent, and Michael Schrum.

## Zupp-Smith runs with incumbents for Denison City Council

Jennifer Zupp-Smith, who has been a frequent participant at Denison City Council meetings and a member of the Crawford County Wellness Center Ad Hoc Committee, is running for the council for the at-large seat that was vacated by Jessica Garcia

Garcia stepped down from her council seat to accept the position of city manager.

Three incumbents are running for election for the City of Denison offices – Pam Sosemen for mayor, Gregory J. Miller for an at-large seat, and John C. Granzen Sr. for the Ward 2 seat.

Following are the people who filed for city elected offices in other cities in the county.

Arion No candidates filed for the mayor's Puck and Kim McAllister filed for reelection. Malone and McAllister are candidates for the two District 1 seats up for election, and Hansen and Puck are running for the two District 2 seats.

**Charter Oak-Ute:** Melanie McAndrews was the only incumbent to file for re-election. She is a District 1 board member. Gregory Amunson filed for the other District 1 seat up for election and Adam Hadden filed for the at-large seat. Kyle Schultz and Tyson Goslar did not file for re-election.

**IKM-Manning:** Mike Blum, Zachary Meiners (incumbent) and Sara Ferneding are running for one atlarge position; Bridget Gore and T.J. Sterk are running for one District 1A position (incumbent is Beth Williams); David Heller (incumbent) and Emmalie Rasmussen are running for one District 2A position; and Jeremy Puck (incumbent) is running to fill a vacancy for an at-large position. # A new college logo symbolizes a bond with students and communities

#### BY GORDON WOLF

Change at the Western Iowa Tech Community College (WITCC) drove the need for a new logo, according to WITCC President Terry Murrell.

He was at the Denison WITCC campus last Thursday to talk about the design of the new logo and the synergistic relationship among the college, students and the community.

"Within the past 10 years we have seen a significant change at Western Iowa Tech. There's a couple of things that we've done that led us to think that maybe we need to have a new look," Murrell told those gathered at the Denison campus building.

One change was the adoption of a new mission statement. The old statement did not have the students at the center of the message, Murrell said.

The new mission statement is: As a comprehensive community college, our mission is to provide quality education and to economically enhance the communities we serve.

The community college's board of directors also adopted new values. The first letter of each value spells the word "TECH" - transformation, engagement, community and harmony.

Another development was being named an Apple Distinguished School three times. Murrell said WITCC is only one of four community colleges to ever receive that designation.

He continued that WITCC has awarded more credentials than any other community college in the Iowa system, which stems from a philosophy of giving students and businesses what they both need to thrive.

"Rather than try to give everybody an associate degree, we try to find out what it is that you're (businesses are) looking for so we can get the students out into the field," Murrell said.

He said one more reason to design a new logo is the work that has been done at the college's buildings.

"Over the last 10 years we have changed almost every one of the learning spaces that we have in the college to try to make sure that those learning spaces are appropriate for what a student might need and for what it might look like when they get out into the field," he said.

Input from staff, students, community residents, board members, alumni and others were considered in the design of the new logo.

"We hope that this logo becomes a visual representation that instills the pride in our college that our students and our community and our alumni are looking for," Murrell said.

Murrell said the purpose of Western Iowa Tech remains the same in its focus to elevate diverse learners and the communities it serves through an inclusive and innovative education.

"I'm a firm believer that Western Iowa Tech can be no stronger than the communities. So really our mission is to help strengthen our communities. By strengthening our communities, we think we're also then helping to strengthen our college and the people going to our college," Murrell said.

Later, before the members of the Denison Rotary Club, Murrell spoke about the plan to add on to the Denison campus building to establish a regional career academy that will involve the Denison Community School District and other area school districts.

He said \$5 million had originally been budgeted for the career academy with WITCC and the Denison Community School District each providing \$2 million. The state also provided a \$1 million grant.

Murrell said the budget hasn't been developed but he did look at the plan and said he would be surprised if the project could be done for \$5 million.

He said it was important to bring in other high schools to broaden and diversify the programs that can be offered to students.

Murrell said that 10 years ago. WITCC did not have any vocational program at the Denison campus. Today nursing, welding and HVAC are offered on campus.

"And I think with the academy, it's going to allow us to bring in a few more

different programs and we will continue to listen to the community as to what your needs are," he said.

Some of the projected new programs are business, education, ag and electrician.

He also spoke about the placement of WITCC students in careers. He said placement was probably an issue in 2008 and before, but if there's a college that's not placing in the 90th percentile right now, he's not sure why they're in business because of the high demand for employees.

Because of the demand, students coming out of high school can earn \$20 to \$25 an hour; it was around \$15 an hour less five years ago, Murrell said. He added that to a high school graduate, \$25 an hour sounds like a lot of money, and it is, but it's not as much money when that high school graduate turns 45 and 50 years old.

Murrell said the issue for WITCC is to support people to get an education while they are out earning the \$25 an hour by offering day classes, online classes or night classes. He said if too many graduates take jobs right out of high school without further education, it leads to a very low skilled community, and if it becomes too low skilled, it will be difficult for communities to attract the businesses they want.

"We really try to work directly with people and get them what they want. Over the last seven years, we've issued more credentials than any other community college in the state," Murrell said.

He pointed out that most community colleges shy away from giving a oneyear diploma or a six-month certificate because they want the kids to stay with them for two years to receive an associate degree.

"Early on we said we need to meet the needs of our students, so if they come to us and say they want a six-month certificate, we're going to give them a six- month certificate. And then we feel strongly that they're going to come back to us and finish up their diploma or finish their associate degree."

Roadways Community Visioning program, a collaboration among the Iowa Department of Transportation, Iowa-based nonprofit Trees Forever and Iowa State University Extension and Outreach.

Those present to explain the drawings of the visioning projects will be Brad Riphagen with Trees Forever and representatives of the landscape architecture firm HDR that did the drawings.

A recent step in Denison's visioning process took place on July 26 at the city hall council chambers. Members of the Denison Visioning Committee and the Uptown Improvement Committee met with Riphagen and with landscape architect Alison Ingunza with HDR and HDR summer intern Caeley Reade, a student at Iowa State University.

Following are the four targets of the visioning program in Denison.

An expanded trail system

Safer pedestrian crosswalks with higher visibility, especially across Highway 30

Wayfinding signs that will more visibly direct motorists to the businesses, services and amenities that the community offers

An expanded Northside Rec area.

The July 26 meeting was one of the final ones before the designs for each of the target areas were refined and attached to display boards. Ingunza and Reade took the feedback they received from the meeting, did more investigation and research into making those changes and then presented the revised versions to the Visioning Committee.

On Thursday, November 2, the designs will be presented at the annual community visioning celebration at the Gateway Hotel and Conference Center in Ames. Each community involved in this year's program will present their visioning plans at the celebration.

Prior to the most July 26 meeting, the designs for the visioning targets were made available at a booth at the Immigrant Heritage Festival in Washington Park on June 24.

Before that, HDR representatives had met with committee members at

least two times, and prior to that people had the opportunity to help shape what the target areas would be through focus group meetings on March 4.

Following are the points of the visioning plans.

#### Trail extensions

The intent of this visioning component is to connect Denison with the Wheels to Heels and Yellow Smoke trails.

Information from HDR's drawing says the proposed route will create a more than 10-mile loop, connecting the Yellow Smoke Lake Trail to downtown, the Walmart Supercenter, and on to Crawford County Memorial Hospital.

The proposed trail corridor would incorporate three treatments: sharestreet sharrows (road separation markings), buffered lanes and sidewalk improvements and landscape enhancements.

#### Highway 30 crosswalks

A solution to making the Highway 30/South 11 Street crossing safer became a possible design for all future crosswalk changes in the community.

Of particular concern at the above intersection is for WESCO Industries clients to safely cross the highway on their way to the WESCO building on the west side of South 11th Street and to the day habilitation building on the east side of the street.

At the July meeting, a suggestion was made to use stained concrete for the crosswalks, and the color of the stain should closely match the red brick that is in the Uptown Denison streetscape.

It was suggested that this concept be used for any other crosswalk improvements made in Denison.

#### Wayfinding signs

Directing motorists off Highway 30 to the businesses, services and amenities north and south of that corridor has been a concern for other groups, such as the Uptown Improvement Committee, the group that is behind the new banners that have been placed in Denison.

Originally, a monument-style sign was suggested, but the Department of Transportation would not approve that style, and break-away signs are now in the plan.

#### Northside Rec

The drawing for this proposed project shows two soccer fields and two little league ball fields in the middle of 60 acres owned by the Weis family north of North 9th Street and west of North 20th Street.

HDR's concept is that the two ball fields and the soccer fields would be grouped together in the Weis property. Because of the hilly terrain, the soccer fields would be tiered, one at a higher elevation than the other, with a terrace between them.

The design also envisions a trail within the area.

#### NOTICE OF ADDITIONAL INFORMATIONAL MEETING **ON TRANSMISSION LINE PROPOSED TO BE CONSTRUCTED** IN CRAWFORD COUNTY, IOWA **DOCKET NO. E-22430**

Notice is hereby given that an additional informational meeting will be held on October 18th, 2023 at Boulders Conference Center located at 2507 Boulders Drive, Denison, IA 51442 starting at 5:30 PM (CDT).

Silver Queen Wind Farm, LLC, a limited liability company, whose principal place of business is located at 5775 Flatiron Parkway Ste 120, Boulder, CO 80301 and whose mailing address is the same as above, has filed a Petition with the Iowa Utilities Board for authorization to construct and collocate the current 69kV electric transmission line with a new 230kV transmission line along the proposed route:

The proposed line will originate from the existing WAPA Denison electric substation, located southwest of Denison, Iowa near the intersection of Westcott Road and R Avenue in Section 29, Township 83N, Range 39W in Crawford County. The current petition provides that the proposed line will proceed approximately 0.8 miles southeast along R Ave and 240th Street, 13.5 miles east and 1.5 miles north along the half-section lines, 0.5 miles east along Q Avenue, and then 1.5 miles north along 380th Street to terminate at the proposed interconnection electric substation that will be located in proximity to Northwest Iowa Power Cooperative's existing Halbur Substation that is southwest of the intersection of 380th Street and O Avenue in Section 15, Township 83N, Range 37W in Crawford County.

A public informational meeting concerning the proposed line was held March 5, 2020, prior to the Petition being filed. Silver Queen Wind Farm, LLC has subsequently determined that an alternate route may be necessary at one location along the original proposed route, which could impact a landowner that was not included in the original notification corridor. Therefore, an additional public informational meeting is being scheduled to provide the parties affected by the alternate route an opportunity to receive information about the proposed transmission line, the Iowa Utilities Board process, and applicable landowner rights.

The proposed re-route will impact properties located in Section 35 and 36, Township 83N, Range 39W in Crawford Street, and extends south to the S 1/8th line or South Section line and then extends

East to a point on the west line of Section 36 of said Township and Range, crossing Highway 59, and then extending North along said west line of Section 36 to the half section line where it rejoins the original preferred route and extends east along the half section line. The re-route will involve a single circuit 230 kV line, as the existing 69 kV line will remain along the half section line at the location of the re-route. The proposed re-route is reflected on the attached map.

The proposed transmission line in Crawford County Iowa is a part of a proposed wind generation project in both Crawford and Carroll Counties Iowa consisting of up to 78 wind turbines (depending on turbine technology) with a total generating capacity of approximately 255 MWs total that might be built in one phase or multiple phases. The wind turbines will be connected to 34.5kV underground gathering lines which will interconnect to the proposed wind farm's substation. The proposed 230kv transmission line will be used to transmit the wind farm generation to the grid and the Southwest Power Pool (SPP) market. Petitioner intends to construct the majority of the transmission line on private property, following the existing transmission lines' paths, except for the location of the proposed re-route.

The Petitioner will seek to acquire easements over private property as necessary to construct, operate, and maintain the transmission line. The double circuit line will be constructed on a single pole made of steel. The width of the easement sought is 150 ft total, 75 ft from the centerline of the pole. Where needed, additional temporary construction easements will adjoin the permanent easements. The easement request included the right of ingress and egress to and from the easement area as well as the right to trim trees and vegetation that may interfere with construction, operation, and maintenance of the line. The landowner, however, may use the surface area of the easement strip for any purpose that does not conflict with the operation of the line.

Your receipt of this notice indicates that your property, or property in which you have an interest, may be affected by the proposed re-route and construction of this line. As a landowner or party in possession of or residing on the property that may County. The re-route would provide that possibly be affected by the location and the preferred route deviates from the half construction of this proposed line, you have section line before or after crossing 260th the right to be present at the informational meeting to be held at the place and time set forth above. Qualified representatives of the

Petitioner will be present at the meeting to explain the project and answer any questions you may have. You also have the right to file with the Iowa Utilities Board written objections to the proposed transmission line. Written objections may be filed by using the Utilities' Board's electronic filing system at https://efs.iowa.gov/efs/ or by mailing them to: Iowa Utilities Board, 1375 E. Court Avenue, Room 69, Des Moines, Iowa 50319-0069.

It is possible that the Petitioner may acquire the right-of-way by condemnation if approved by the Iowa Utilities Board (IUB). The IUB will decide on whether to approve the Petitioner's franchise petition and whether to grant Petitioner the right to take property by eminent domain. Under Iowa law, private property cannot be taken for public use without just compensation. This means that if the property rights cannot be acquired voluntarily and it becomes necessary to "take" an interest in property, (a) the proposed project must be needed to serve the public use, (b) the proposed project must represent a reasonable relationship to an overall plan of transmitting electricity in the public interest, and (c) there must be just compensation. In Iowa, when an electric utility desires to take an interest in property in this manner, which is called eminent domain or condemnation, the Utilities Board determines under Iowa Code Chapter 478 whether the Petitioner has shown a need to serve the public use. The matter of just compensation for the property rights taken by eminent domain is not determined by the IUB. It is determined by a Compensation Commission appointed from your county.

At this time, the Petitioner does not have the right of eminent domain. In other words, it does not have the right of condemnation. The right of eminent domain may only be granted by the Utilities Board after a public hearing on the eminent domain request. If the right of eminent domain is granted by the IUB, it is granted for the life of the proposed transmission line.

You will receive written notice of the public hearing if the right of eminent domain is requested by the Petitioner, to acquire the right to place the proposed electric transmission line on your property. You have the right to file written objections to the proposed project with the IUB setting forth the nature of your objections. You also have the right to appear before the IUB at any and all hearings with or without the aid of legal counsel.

The IUB does not supervise or control negotiations for the purchase or acquisition of voluntary right-of-way easements for electric transmission lines. Once the informational meeting held pursuant to this Notice has been conducted, negotiations are strictly between you and the Petitioner either with or without your use of private counsel.

At the formal franchise hearing before the IUB, objectors will be given the opportunity to cross-examine the Petitioner's witnesses and to present witnesses on their own behalf. The burden is on the Petitioner to prove the necessary elements of its petition.

The IUB is not an advocate or protector of any particular landowner or landowners. The IUB only determines whether a proposed electric transmission line is necessary to serve the public use, and whether it represents a reasonable relationship to an overall plan of transmitting electricity in the public interest. If you believe you need to be represented by an attorney in this matter, you may retain one at your own expense.


The decision whether to grant the franchise and/or the right of eminent domain will be made by the IUB. The Utilities Board may appoint a hearing officer to preside over the hearing and issue a proposed decision. This proposed decision will become the final decision of the Utilities Board unless it is appealed to the Utilities Board by a party to the case within the time limit provided in the proposed decision. When the Utilities Board has decided the case, either initially or on appeal from the proposed decision, any party to the proceeding may file for rehearing within 20 days. Once a final decision has been made, any party may appeal to the District Court within 30 days.

A representative of the IUB will be present as this informational meeting and will distribute and review a statement of individual rights as required under Iowa

In 2022, CCHappy Cats was able to spay or neuter 47 cats, and so far this year, the 501(c)3 organization is on track to spay or neuter 180 cats.

CCHappy Cats is the brainchild of Masha Bachmann. It has been in existence for just a year and a half but was four or five years in the making.

Its mission is to improve the lives and health of community cats and kittens in Crawford County through community outreach, humane education, spay and neuter programs and adoption.

Last week Tuesday Bachmann, Nancy Voggesser and Tony Lile gave a presentation about CCHappy Cats to the Denison City Council to raise awareness of the organization's mission and to put the word out about the need for donations and for volunteers.

Voggesser became involved with CCHappy Cats because of her experience with the Harrison County Humane Society's low-cost spay and neuter clinics. That was when she lived in Logan.

"It was just for Harrison County," Voggesser explained, "and I would get emails constantly from people in Denison and people in Crawford County saying, 'Can we get in on this?""

When she moved to Denison, Bachmann asked Voggesser to help with CCHappy Cats.

"One of the things that we have really dedicated ourselves to doing right off the bat - and we've been going for about a year and a half now really strong – is low-cost spay and neuter clinics," Voggesser said.

Fifteen cats are spayed or neutered at the monthly clinics. CCHappy Cats works with Tarin Clausen, who used to

be at a veterinary clinic in Denison and now has her own clinic in Schleswig. Clausen does the spaying and neutering at the CCHappy Cats building at 720 Broadway.

Voggesser explained that the cat owner pays \$40 toward the spaying or neutering. The cat is vaccinated and microchipped. Donations and money from fundraisers allow CCHappy Cats to pay the balance of the fees.

CCHappy Cats also has a trap, neuter and release (TNR) program that spays or neuters and vaccinates feral cats.

As of last Tuesday's presentation, the organization had treated 143 cats through the low-cost clinics and 55 cats through the TNR program.

Not all cats are from Denison, but quite a few are, Voggesser said.

She said if each of the 198 cats treated so far in 2023 would have been responsible for five kittens each throughout the year, the work of CCHappy Cats would have curbed the overpopulation of cats by 990 kittens.

"Right now, one of our big needs is boosting our fundraising in the community," Voggesser said.

Meeting with the city council was one way to get that word out. Voggesser said the organization hopes to meet with various service organizations.

A shelter and adoption program is part of CCHappy Cats, but it has taken on a role of less priority at this time in lieu of the low-cost clinics and the TNR program.

Bachmann explained that the time involved in caring for cats in the shelter takes away a lot of time from running the TNR program and making public presentations about the mission of CCHappy Cats.

"As we grow and we get more volunteers and get more community involvement, our shelter will grow as well and we will have more cats up for adoption, and we will be able to focus on that aspect of our mission as well," Voggesser said.

Lile explained how the TNR program works.

A resident will call CCHappy Cats about a feral cat problem in their neighborhood. Lile, who does most of the TNR work, will trap the cats, take them to a local veterinary clinic to be spayed or neutered and vaccinated, and a day or two later when it is safe to do so, the cats will be released at the location where they were trapped.

Bachmann explained that the TNR program helps to keep cats healthy and makes sure they are no longer able to breed.

"Generally, it cuts down on the bad behavior of yowling and the fighting, and there's less smell and less noise, and there will still be rodent control," she said.

Funds and volunteers are needed, said Voggesser

"When we start do TNR in neighborhoods in Denison, we will need people to volunteer to watch the traps and do some transport as well," she added.

Currently, Lile does a lot of the trapping, and he lives in Manilla.

"Having the community take part in this program is huge in helping us to keep it going," Voggesser said.



"A lot of cattle guys use them," he said.

Blank Park Zoo of Des Moines has purchased several to provide shade for their giraffe and rhinoceros enclosures.

The new building in Denison is 150 feet by 80 feet, with an attached office, and will be dedicated to manufacturing Mohr Shades when complete.

"We'll be doing all the fabrication down here instead of in Schleswig," Mohr said.

The new building will allow the business to expand into additional products.

"We're coming out with a couple other models and sizes," he said. "We came out with a new one last year, and we'll have right at five different models this upcoming year."

The shades are popular, in part, because of their easy-to-use design.

"Mohr Shade, less hassle' is our slogan," Mohr said.

Concrete was poured at the new building in Denison on Monday.

Mohr said he expects construction to be complete and to move into the building within a month.

Because production of the shades has been ramping up over the last several years, most of the necessary staff is already in place, but Mohr plans to hire one or two additional individuals when production begins in the new building.

"We'll build all winter," he said. "We're hoping to see more than 300 shades for next year."

## An unmodified opinion CCMH audit delivered

"We are issuing an unmodified opinion – that's essentially stating it's a clean opinion for the two years presented," said Jay Horn, CPA Partner with Denman and Company of West Des Moines.

Horn attended the September 25 Crawford County Memorial Hospital (CCMH) Board of Trustees meeting to present the fiscal year 2023 CCMH audit.

An unmodified opinion is what the hospital strives to receive when undergoing an audit, he said.

Fiscal years 2022 and 2023 were presented in the audit statement with additional comparisons to 2021.

Horn led the trustees through a look at the primary financial numbers in the 53-page report, which was pared down was \$36,374,000, an increase of 5% to a PowerPoint presentation for the meeting.

pleased with the cash positions," Horn said.

The audited assets had a combined value of \$45.7 million; of that, cash and investments totaled about \$21 million.

Horn said CCMH was in a "solid position" with cash, which he said would be useful for the hospital's proposed expansion project.

He noted that a concern 15 years ago, when construction of the new hospital was being considered, was whether the cash position at CCMH would hold throughout the life of the project.

"And fortunately, it has," he said.

Gross revenues for 2023 were \$66,485,000, which was an increase of 9% over 2022; 2022 had a 9% increase over 2021.

The most significant increases in revenue in 2023 came from the CCMH observation room, the pharmacy and \$1.62 million in 2023, which was a 20% increase from 2022. 2022 had a decrease of 9% from 2021.

As part of the bad debt discussion, CCMH President and CEO Erin Muck noted that Crawford County currently has an uninsured population of about 11%, which is up 2% from a year ago; Crawford County's uninsured rate is significantly higher than the rates of Carroll and Shelby counties.

Horn said the audit showed that the hospital's total expenses were \$39.8 million for 2023, which was an increase of 11%; salary expenses, with a total of \$19.8 million, were up 8% over 2022.

He said other hospitals are reporting similar increases and said inflation was one of the drivers.

"Other expenses," at \$16.5 million, were up 19% from a year ago; the largest increases were in the emergency department and the clinics. The hospital's depreciation expense for 2023 was \$2,603,000. Horn noted that the depreciation expense has remained fairly stable from year to year – and could increase with a new expansion project.

Interest expenses were \$772,000 in 2023, a decline from \$865,000 in 2022.

Horn said hospitals had seen volatility in net income following the pandemic due to provider funds provided by the government; CCMH's net income in 2021 was \$2,609,000; \$3,832,000 in 2022; and \$1,797,000 in 2023.

Horn said the hospital's 2023 debt service coverage ratio of 2.83 was above the target of 1.25.

Board of Trustees Chairman Jay Mendlik explained that the debt service coverage ratio is essentially a requirement that the hospital have \$1.25 of net income for every dollar borrowed.

"In this instance, we're showing \$2.83 for every dollar we have borrowed," he said.

For the 2023 audit, CCMH had 210 days of cash on hand, down from 233 in 2022 but up from 201 in 2021. Horn said the final step of the CCMH audit process would be to file the audit with the Auditor of the State of Iowa and with the Crawford County Courthouse.

"We felt the balance sheet is in good position, needless to say (and we're)
